Green Belt/ Metropolitan Open Land	Comprise the following: Green Belt: A national policy designation (PPG2 Green Belts 1995) which aims to contain development, protect the countryside, preserve the setting and special character of historic towns and assist in urban renaissance. London’s Green Belt is protected by policy contained in the London Plan (2002) with detailed boundaries defined in Unitary Development Plans. Metropolitan Open Land: A designation unique to London designed to protect strategic open land in urban areas that contribute to the physical structure of London by being clearly distinguishable from the built-up area. The London Plan affords MOL the same level of protection as the Green Belt. It is the responsibility of the London Boroughs to designate MOL through the UDP process, in consultation with the Mayor.
